




Summary of Nevada Avenue Monthly Sampling Results – Tetrachloroethene (PCE)

 - Draft Final, September 2014
 - Final, October 2014
- Monthly Army sampling of Nevada Ave private wells continues until March 2015
- Bottled water under new contract, one year with two option years
